



CATEGORIES OF NAB MEMBERSHIP

TIER ONE (*individual licensees : Commercial broadcasting and Public broadcasting of national and regional scope whether provided FTA or Subscription*)

If you hold an ICASA individual broadcasting licence or individual broadcasting signal distribution licence, you are eligible for full membership of the NAB. Tier one members participate in all NAB Committees and Activities.

TIER TWO (class licensees)

If you hold an ICASA Class (community) licence, you are eligible for Tier Two membership and participate in the Community Radio and/or Community TV Committees of the NAB. You have access to all NAB newsletters, industry updates, NAB research and participation in NAB roundtables and events.

TIER ONE AND TIER TWO BROADCASTERS ARE ALSO SIGNATORIES OF THE BCCSA CODES OF CONDUCT FOR BROADCASTERS (WWW.BCCSA.ORG.ZA)

TIER THREE (Associate member: a business or individual associated with broadcasting/media/Audio and Audio-visual content services)

If you are a non-licensed entity, or an individual or business associated to broadcasting and/or or an authorised channel (on an individual licensee's bouquet), then you are eligible for Tier Three membership. You have access to all NAB newsletters, industry updates, NAB roundtables, events and NAB Research.

Once a membership form is completed (see below) and the NAB Exco has considered and approved the membership, an invoice will be generated for payment. The NAB reserves the right not to approve membership.
